Protect Your Store From Robberies

- Remain alert to suspicious behavior.
- Establish a prearranged code word to alert associates when necessary.
- Contact law enforcement of any perceived imminent danger or suspicious behavior.

When you close for the day:

- Never close alone.
- Have another associate observe the store closing from a safe distance outside with a cell phone.
- Pre-arrange a visual "all clear" signal with your lookout before leaving the store.
- Always make sure you're not being followed after you leave.

Sometimes jewelers follow all security precautions and still become victims of robberies. If this happens, it's important to cooperate fully with the robber's instructions. Never resist.


